**DEFENDANTS' MOTION TO DISMISS**

Defendants, M. Jodi Rell, in her official capacity as former Governor of the State of Connecticut; Allan B. Taylor, Beverly Bobroske, Donald Coolican, Lynne S. Farrell, Janet M. Finneran, Theresa Hopkins-Staten, Patricia B. Luke, and Timothy J. McDonald in their official capacities as present and former Members of the State Board of Education; Betty J. Sternberg, in her official capacity as former Commissioner of Education of the State of Connecticut; Denise L. Nappier, in her official capacity as former Treasurer of the State of Connecticut; and Nancy S. Wyman, in her official capacity as former Comptroller of the State of Connecticut, hereby move for the dismissal of the above-captioned action pursuant to Practice Book Sec. 10-31(a)(1) and Sec. 10-33. In support of this motion, the defendants submit that the complaint should be dismissed in its entirety because the court lacks subject matter jurisdiction over the plaintiffs' claims based on their lack of ripeness and, in addition, their mootness. Furthermore, plaintiff CCJEF's claims should be dismissed for lack of standing. A memorandum of law in support hereof accompanies this motion.

WHEREFORE the Defendant respectfully requests that the Court grant this motion to dismiss due to lack of ripeness, mootness, and lack of standing.

ORDER

The foregoing motion, having been heard, is hereby GRANTED/DENIED.


